General Session I - Wednesday, 1:30 p.m. - 3:00 p.m.

"Getting to Know Your Neighbors: The Importance of U.S.-Mexico Collaboration in Higher Education" Francisco Marmolejo, Executive Director, Consortium for North American Higher Education Collaboration (CONAHEC), University of Arizona



Francisco Marmolejo serves as executive director of the Consortium for North American Higher Education Collaboration (CONAHEC), a leading network of 120 colleges, universities, and higher education organizations from Mexico, the U.S. and Canada, headquartered at the University of Arizona. CONAHEC is recognized for its instrumental role in furthering higher education collaborative efforts in the NAFTA region. Its services include a U.S.-Mexico borderlands higher education network called "Border PACT;" its North American Student Exchange Program, its Internet portal, and the Student Organization of North America. Previously, Marmolejo was an ACE fellow at the University of Massachusetts, Amherst—the first Mexican selected to participate in this premier higher education and

finance and vice president for academic affairs at the Universidad de Las Américas in Mexico City (UDLA). During his tenure at UDLA, the institution was the third university in Latin America to obtain accreditation in the U.S. from SACS. Marmolejo has taught at several universities in Mexico and also served as director of the Mexico City Center of PROFMEX (a consortium for research on Mexico) and is currently on their board of directors. Marmolejo consults for Mexican and South American universities, as well as for the Mexican Ministry of Education (SEP) on issues related to administration and international initiatives. At SEP, he led efforts to create the national standards for accounting and financial information for colleges and universities. Marmolejo holds an M.B.A. from the Universidad Autónoma de San Luis Potosí), and has conducted doctoral work at UNAM.

<u>General Session II - Thursday, 9:45 a.m. – 10:45 a.m.</u>

"TAIR Me a New One", Horace F. Griffitts, Professor Emeritus, Tarrant County Junior College, Fort Worth, Texas and William F. Lasher, Vice Provost and Professor at The University of Texas (UT) at Austin



From 1969 to 1992, Dr. Griffitts was Director of Research at Tarrant County Junior College. Prior to that, he held a series of faculty positions at Texas Tech University, Michigan State University, University of Texas at Arlington and Sam Houston State University. He is author of several periodical and yearbook articles in the area of business education and community college education. He holds several professional memberships (now emeritus) including the Texas Association for Institutional Research. He is a frequent speaker at area civic, education, and professional organizations. Dr. Griffitts has a Ph.D. in Higher Education Administration from Michigan State University.



Prior to his current positions at UT in Austin, Dr. Bill Lasher held number administrative positions at UT, including Director, Office of Institutional Studies and Associate Vice President for Budget and Institutional Studies, and Associate Dean in the College of Education. He has also served as a UT faculty member teaching numerous courses in the department of Educational Administration. Dr. Lasher has written several book chapters and monographs, and published several articles. He has served as liaison between UT and the Texas Higher Education Coordinating Board, the Southern Association of Colleges and Schools, and the 77th Texas Legislature for actions concerning academic legislation. Dr. Lasher is also the former president of AIR.

Bill and Horace served as part of the Program Committee for the first TAIR conference in Austin in 1979. As part of our 25th TAIR anniversary celebration, our esteemed colleagues will talk about the beginnings and evolution of TAIR.

Lunch & General Session III - Thursday, 12:00 - 1:45 p.m.

"Exploring the Murals of El Paso" Carlos Callejo, artist



A long-standing advocate of public art, Mr. Callejo has dedicated much of his career to the creation of murals in the barrios throughout the United States and abroad. He is one of El Paso's most celebrated artists, having been invited by the Smithsonian to create a mural as well as having been the recipient of a much coveted Leila Wallace – Reader's Digest Fund – Arts International grant that provided him the opportunity to study the history and production of murals in Italy. Mr. Callejo is an artist who produces work for the specific purpose of promoting the values of community interaction. He has taken inspiration from the great muralists of post-revolutionary Mexico, but has

expanded their message. His work is filled with images of the past both mythic and real, and he has drawn upon the unmistakable landscape of the American Southwest and Mexico as a dramatic backdrop. Carlos Callejo has tailored this presentation of the Murals of El Paso for the TAIR membership.

Sharron L. Ronco, Assistant Provost for Institutional Effectiveness and Analysis at Florida Atlantic University in Boca Raton, Florida



Sharron L. Ronco is currently Assistant Provost for Institutional Effectiveness and Analysis at Florida Atlantic University in Boca Raton, Florida. She earned a Ph.D. in Research and Statistics from the University of North Texas, and spent twenty years working in higher education in Texas; first at the Dallas regional office of the U.S. Department of Education and later as Director of Institutional Studies at the University of Texas El Paso. In her current position at FAU, she oversees institutional research, surveys and analysis, and assessment for institutional effectiveness. She co-directed the university's recent (successful) reaffirmation of accreditation visit from SACS. Dr. Ronco has been active as a presenter and program committee member for AIR, TAIR and SAIR. She is co-chairing the Local Arrangements Committee for the 2003 AIR Forum in Tampa.

Nominees for Vice President / President Elect

Karen Laljiani

Dr. Karen Laljiani is the Assistant Dean of Institutional Effectiveness and Research at El Centro College. Prior to joining the Dallas County Community College District, Karen was a Research Associate at the University of Texas at Arlington, where she also taught Psychology. Before entering higher education, she worked in Research and Testing in the Richardson Independent School District. She received a B.A. in Psychology from Boston University and a Ph.D. in Human Development & Communication Sciences from the University of Texas at Dallas.

Dr. Laljiani has been an active member of TAIR since 1994. She designed the first TAIR Web Page, which she managed for four years, until she was elected Treasurer in 1999. After two years as Treasurer, Dr. Laljiani took on the new role of Newsletter Editor. She has been a member of the Program Committee since 1998, and a member of the Local Arrangements Committee in 1999. She is currently a member of the Web-based Membership Directory Committee. She has regularly presented workshops, roundtables, and papers at annual TAIR conferences. This year, she is a co-presenter for the Newcomer's Workshop.

Dr. Laljiani has been an active member of many professional associations in higher education. She has presented papers and/or workshops at AIR, the League for Innovation in the Community College, and the North Texas Community College Consortium (NTCCC). She has chaired the NTCCC Institutional Research Committee, and served on committees and facilitated sessions for SAIR. TAIR is the primary source of professional development for Institutional Researchers in Texas. This course will introduce the two basic steps used to process a SAS program. SAS processing is the way that the SAS language reads and transforms input data and generates the kind of output that you request. The DATA step and the procedure (PROC) step are the two steps in the SAS language. Generally, the DATA step manipulates data; and the PROC step analyzes data, produces output, or manages SAS files. These two steps used alone or combined, form the basis of SAS programs.

As UTEP's College of Engineering began its self-study in preparation to meet rigorous ABET re-accreditation criteria, its faculty sought technical assistance to document the success of its baccalaureate graduates. The Center for Institutional Evaluation, Research and Planning designed an alumni survey and follow-up research based on state wage records with support from the Texas Workforce Commission. Attempts to address external requirements for such follow-up information to guide continuous academic program improvement remain challenging within increasingly restrictive interpretations of the Family Education Rights to Privacy Act (FERPA). In addition to outlining the two processes and their findings, current issues of confidentiality will be explored.

A3 – Maximizing Classroom and Class Lab Utilization

Efficient use of physical resources, especially classrooms and class labs, plays an important role in assessing institutional effectiveness. They are also used to evaluate resources under the comprehensive standards of the principles of accreditation put together by SACS. This presentation will explain how the THECB calculates utilization. It will also outline some steps to take whereby an institution can maximize classroom and class lab utilization.

The second phase of the research uses the CIRP Freshman Survey and the new YFCY First Year Survey to measure student inputs and outcomes. In addition to open discussions of access and fairness, a major function of the Task Force was the review of data generated internally at UT-Austin, and externally by ACT, Inc. and the College Board. The findings of the Task Force are summarized in this session.

A variety of student data files and selected variables for each fall and spring semester were merged to build the database. Other SACS institutions will look to their peers that participated in the pilot project to find out what it did work and what did not. It will discuss the strengths and the weaknesses of the new process and provide valuable information to those that are going to undergo this process in the near future.

C2 – The Effect of the Community/Junior College Reduced **Tuition Pilot on Space Utilization and Enrollment**

In August 2001, the 77th Legislature passed House Bill 1465, enabling Texas Public Community and Junior Colleges to pilot a reduced tuition plan for students taking classes at times of low enrollment demand "in order to promote greater access to higher education and more efficient use of facilities and resources." The Dallas County Community College District is a pilot site for implementation of this plan. The pilot program began in Spring 2002, and will continue through Spring 2003. This project studies the effects of reduced tuition on student enrollment, space utilization and course offerings in non-traditional time slots.

C3 – Retention Difficulties of Special Populations: A Qualitative and Quantitative Study

Low statewide retention rates for Texas Grant Program students are similar to Angelo State University's rates. A study was conducted among three groups of under-performing students: (1) Texas Grants recipients; (2) Up-and-Coming scholars, local students identified in junior high as potential college students with financial need; (3) Carr Scholars, students awarded scholarships on the basis of performance. All groups entered ASU having completed the Texas Scholars curriculum, yet their retention rates are lower than those for their cohorts. This study isolates reasons for their unexpected performance with the objective of developing effective intervention strategies. It discusses intervention strategies already employed and proposes new interventions. Strengths and weaknesses of the study will also be discussed.

C4. Texas Award for Performance Excellence: An Opportunity for Research

Also contained in this questionnaire are sections asking about the respondent's involvement in various quality-of-effort activities, such as "Used a computer (word processor) to write or type a paper." Do remedial students respond differently than non-remedial students to these items?

Interactive web surveys can be an invaluable tool to evaluators requiring immediate ratings. Education Research and Assessment was asked to develop an interactive Internet assessment tool for a team of M.D. Anderson Cancer Center physicians and staff hosting an annual competition in Japan. The group was to select four candidates for a medical exchange program in breast oncology. It was important that the process be fair, and results be available immediately to the team so that they can select the candidates and two alternates. 1. An Introduction to Correspondence Analysis Christopher P. Benton, Alvin Community College Gale Stuart, Texas A&M University – Corpus Christi

Developed in the late sixties, correspondence analysis has long been popular in France as a method for carrying the analysis of contingency tables one-step further. The end result is similar to that of factor analysis in that it provides information on the relationships between various items. This particular presentation will provide a brief introduction to the theory and application of correspondence analysis using SPSS as well as a comparison with more familiar techniques such as factor analysis.

2. The Learning College: Putting It All Together Through IR

David Andrus, Carol LaRue, Del Mar College

The president has just announced that we are from this day forward to consider our institution a "Learning College." Now everyone is wondering what this means and what we will be doing to meet this new challenge. Community college innovators and leaders have been working on this model for well over a decade. The League for Innovation in the Community College has developed the Learning College Project, designed to provide opportunities for intercollegiate collaboration to help community colleges fulfill their commitment to learning-centered education. This roundtable presentation will focus on the objectives, strategies, and best practices that have come out of the Learning College Project. We will share exemplary information, publications, and other resources that show how the Office of Institutional Research and Effectiveness serves as a clearinghouse, resource center, coach, and moderator for all the diverse efforts that becoming a learning college demands.

3. Creating Better Surveys David Preston, Brazosport College

Creating a survey seems like a rather easy task to do. Write the questions, determine the possible answers and create and publish the form. However, if done correctly, creating the survey you need may not be a simple task. There are dos and don'ts and one certainly wants to collect data that when analyzed, will provide the information needed. The moderator of this roundtable will discuss how to create the survey you need.

4. Web Savvy Information for Your Campus Community Debra Hollingsworth, Peggy Johnson San Jacinto Coll. District

What web information is most useful for the multi-campus community college? What format should the on-line reports be published in? How accessible are these on-line reports to the college staff? How should on-line reports be organized on a web page? These are some of the items that will be discussed at this roundtable. Examples of some of the on-line reports located on the San Jacinto College District Research web page will be provided.

5. Processing the Silver of Academic Assessments Dick Roach, Texas A&M University - Texarkana

6. Best Practices for Alumni Surveys

Alumni surveys support an institution's assessment process by collecting feedback at both institutional and program levels. A valid process ensuring relevant questions, a representative sample, widespread dissemination, and thoughtful analysis is needed to provide accurate and useful information regarding the alumni's experiences. Results from an online survey of Texas institutions describe how Texas institutions design, administer, analyze, and present alumni surveys. Responses to these main questions will be reported:

- How are alumni surveys typically administered?
- What is a typical response rate and are there any special techniques or considerations used to increase response rates?
- How are alumni survey data used?

7. THECB – Hot Topics James Dilling, David Gill, Kenneth Dalley, Texas Higher Education Coordinating Board

The panelists will update researchers on current events at the Texas Higher Education Coordinating Board. Topics may include: Federal Educational Rights and Privacy Act (FERPA); redisclosure of directory and non-directory information; student tracking; Automated Student and Adult Learner Follow-up System (ASALFS); Texas Academic Skills Program (TASP); effectiveness of developmental education; CBM reporting changes; formula funding; and Information Access Initiative. Comments, suggestions, and questions are welcome.

8. Implementing an On-Line Student Evaluation of Instruction for Distance Education at a Large Urban College

Linda Gibbs, Margaret Drain, Houston Comm. Coll. Syst.

Presenters will review the development, pilot testing and implementation of an on-line Student Evaluation of Instruction (SEOI) for Distance Education at a large urban community college. The software utilized and the resulting data will also be discussed. Resource materials will be distributed.

9. SAS System Procedures Used To Produce CBM008, The Faculty Report Mary Ann Gregurich, The University of Texas MD Anderson Cancer Center

The CBM008, Faculty Report, is a collection of data on the academic duties and services of each person who has any type of faculty appointment, regardless of their source of funds or their assignment, including teaching assistance. Generating this report using SAS to illustrate features such as creating formats, how to calculate semester salaries and appointments, computing rank and tenure and setting defaults will be discussed.

10. Survey Management and Reporting for a Multi-Campus Institution Mary Ballew, Miriam Barrera, San Jacinto College District

As with most multi-campus institutions, San Jacinto College District (SJCD) has three distinct campuses with very different data reporting needs. Designing survey instruments to meet the needs of all three campuses and still show comparative data between all of them can be difficult. Items of discussion will include: how to use an existing standard survey instrument or design a generic survey instrument to generate comparative data between campuses, data reporting methods that highlight the statistical results of comparative data for the end user, using inserts containing additional questions in conjunction with generic survey instruments to gather information for individual college groups.

11. AIR Professional Development Activities – Some for Free!

Maryann Ruddock, The University of Texas at Austin

TAIR's parent organization – AIR – offers a multitude of opportunities for professional development. The AIR Professional Development Services Committee is charged with "meeting the professional development and continuing education needs of members of the Association." In addition to various pre-forum workshops and the AIR Institute Series, there are a number of fellowships and grants available (read: free money). This session will highlight some of those opportunities, especially the AIR Summer Data Policy Institute. The summer Data Policy Institute is a 12-day chance to study large, national databases in Washington, DC. Other opportunities offered by AIR are dissertation fellowships, research grants, and senior fellowships.

12. SOCRATES: County Narrative Reports Ruben Garcia, Texas Workforce Commission

SOCRATES is the Texas Workforce Commission's widely used labor market planning tool. The reports generated from SOCRATES are used to determine a workforce investment board's targeted occupations list. The County Narrative Report (CNR) is the latest module available within SOCRATES. The CNR provides a multitude of countybased statistical data for program planners and institutional researchers. This roundtable session will provide information on the data available in the CNR.

13. Geographic Mapping: A Promising Tool for Institutional Researchers Sarah Enticknap, The University of Texas Medical Branch

Much of the demographic data about our students and faculty can be presented as spatial distributions. At UTMB we are presenting the statewide, national, and global characteristics of our students in the form of geographic maps. Such maps can help target recruitment efforts, identify predictors for retention, and show which geographic areas successful graduates come from. Community colleges and smaller schools can trace the characteristics of students originating from particular counties, cities, census tracts, and even blocks in their catchment areas. This roundtable discussion will focus on the utility of maps to describe data, and the software available for doing it.

14. SPSS Survey Research Solutions: How to Achieve Better Survey Results in Less Time Meta Brown, SPSS Inc.




