Welcome to Austin and TAIR 2006!

While not literally true, it is certainly politically true that in Texas “all roads lead to Austin”. We are delighted that our paths are destined to cross at the Austin Radisson, just blocks away from the seat of our government at the capitol building; just feet away from the Congress Bridge, which houses the largest natural collection of bats in Texas; and just steps away from 6th Street entertainment, jazz, and excellent dining facilities. Of course, the Commissioner of Higher Education and the Texas Higher Education Coordinating Board are at the center of the Texas educational world, and we are fortunate enough to be able to cross paths with these influential people at the conference, as well. The Commissioner will speak at our opening General Session, and the Coordinating Board have been an integral part of the planning team, with Susan Brown chairing the local arrangements committee, Gabriela Borcoman, their newest recruit and long-time TAIR member, editing the conference brochure, and their Board Room serving as the off-site location for hands-on SAS workshops during the pre-conference professional development series.

The executive committee has taken your input on the Strategic Plan seriously, and has heeded advice to increase the professional development opportunities, particularly by increasing the number and variety of workshops available. In order to accommodate the increased number of workshops, we have expanded the schedule to begin a half day earlier, so workshops will be offered all day on Tuesday, as well as the usual Wednesday morning selection.

Around 45% of the respondents to the SWOT survey have been employed in Institutional Research for less than five years, and a large number of newcomers arrive at their first TAIR conference each year. We always have paid close attention to the needs of the newcomer population, but this year we have expanded the newcomer workshop, and Marilyn Greer, who attended a “Train the Trainer” workshop at AIR, will bring us the “Foundations of IR” workshop on Wednesday morning, followed up on Friday with the usual panel of veteran IR professionals, who are eager to share their collective wisdom. **Early arrivals are encouraged to join newcomers, the executive committee, and local TAIR members for dinner on Monday night.**

One-third of the respondents said that they had two or less employees in their offices, and desires were expressed for a forum to discuss issues specific to this population. Amy Bawcom has initiated a new special interest group, “OPIRO”, for one person IR Offices, which debuts this year.

There are many more ideas that you all have expressed to us during the planning process that need additional time for exploration. The executive committee is proposing a few changes which we hope will allow for thoughtful contemplation that will lead TAIR to the next level of excellence. You will be hearing more about these proposed changes at the conference, and soon there will be information on the website (www.texas-air.org). Please plan to attend the annual business meeting on Friday morning for discussion and a vote. Can’t wait to see you in Austin, where all our roads will meet!

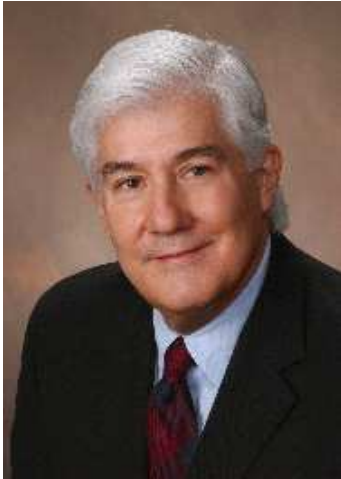

"Accountability in Texas Higher Education and its Implications for Institutional Research"

Raymund Paredes, Texas Commissioner of Higher Education



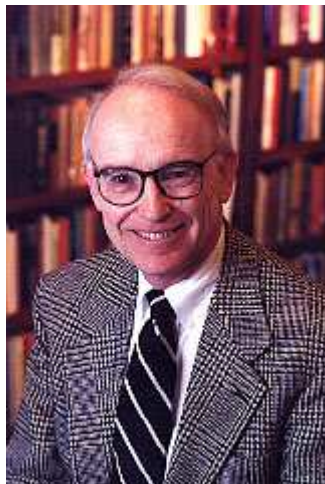
Dr. Paredes was appointed Commissioner of Higher Education in 2004. A former faculty member and administrator at UCLA, Dr. Paredes has extensive experience in student outreach efforts as Vice President for Programs at the Hispanic Scholarship Fund. Dr. Paredes' writing career focused on Mexican American culture and literature and he has been a judge for the *Los Angeles Times* Book Prize in fiction, a cultural diversity consultant for National Public Radio, and a consultant on several film projects. Dr. Paredes earned a Bachelor's degree from UT Austin, a Master's degree in American Studies from University of Southern California, and a doctoral degree in American Civilization from University of Texas at Austin.

The accountability system was instituted in 2004 at the urging of Governor Perry, who requested information necessary to determine the effectiveness of higher education. In its second year, the system touches all areas of higher education and is used by the legislators in the decision-making process.

General Session II - Thursday, 9:45 a.m. – 10:45 a.m.

"IR Past/Present and Future."

Larry G. Jones, former SAIR President



Dr. Jones retired recently from the University of Georgia, Institute of Higher Education (IHE), where he was a senior public service associate. Larry also taught institutional research at the IHE. Prior to coming to the IHE in 1991, Larry was the dean of Midland Lutheran College, assistant provost and director of IR at Wittenberg University, and in the IR office at the University of Georgia. His special areas of interest include institutional research, institutional planning and institutional effectiveness and efficiency.

Larry is a recipient of the Distinguished Membership Award of the Association for Institutional Research (AIR), and has served on the AIR Board of Directors and chaired numerous AIR committees. A past president of the Southern Association for Institutional Research (SAIR), he was awarded Distinguished Membership and is the recipient of the James R. Montgomery Outstanding Service Award. He served for many years as the IHE liaison for the SAIR/IHE Institutional Research Alliance and was the editor of *SAIRendipity*, an electronic and print op-ed column and the editor/manager of SAIRMAIL, an electronic message service of SAIR. In his many roles in the IR community, Larry has been both a historian and a visionary regarding the role of IR in higher education.

Lunch & General Session III - Thursday, 12:00 - 1:45 p.m.

"Evaluating and Explaining Athletic Performance: From Lab to Games of Texas"

Edward D. Coyle, Professor of Human Performance Laboratory, UT - Austin



Dr. Coyle is a "systems physiologist" who has directed the *Human Performance Laboratory at UT-Austin* for 23 years and researched the limits to athletic performance. He studies exercise and physical fatigue and how the various systems of the body (e.g. cardiovascular, nervous and muscular systems) work individually and together attempting to maximize performance and cope with stress. He also has developed laboratory tests to predict performance and monitor the effectiveness of training. Dr. Coyle advises a number of the teams for Intercollegiate Athletics at UT-Austin, he is the "sports nutritionist" for the San Antonio SPURS and he has recently published lab data explaining Lance Armstrong's physiological maturation over a seven year period. As a luncheon speaker, he will tell stories about how hard lab data sometimes gets "spun" by institutions and "human nature" to fit a particular view that

is often comically absurd. How do you explain to coaches that data does not give them the definitive yes or no answer they want?

"THECB Hot Topics including Jane Caldwell on Financial Aid"

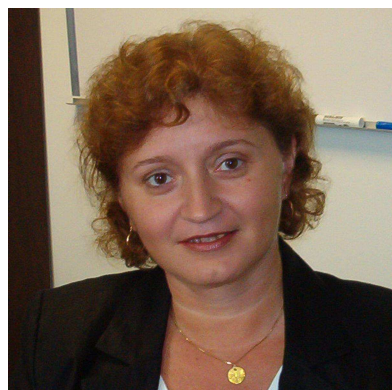

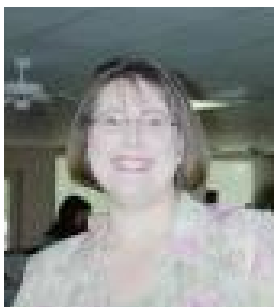

The workshop will include a general description of Enterprise Guide and two demonstrations using data provided by a university as a "real world" example. In the first demonstration, student data will be used to create graphs and summary statistics of student measurements. Logistic regression will be examined as a way to predict the probability of student retention based on these measurements. The second demonstration will examine faculty salaries in an effort to compare the salaries of male and female faculty members. This will be done using descriptive statistics, ANOVA, and ANCOVA. The workshop will also address how to use the output obtained from the statistical analyses to easily write reports and give presentations about your findings.

Accurate enrollment predictions allow higher education planners to allocate resources and plan for infrastructure expansion more efficiently. Using Texas Woman's University application data and prior knowledge of historical patterns, the total 12th day new undergraduate student enrollment is predicted using a Bayesian multiple logistic regression model. Given a pool of applicants, for the 2 test years, the model predicts with less than 2% error the total number of first-time incoming freshmen undergraduate students enrolled. The model results and its specific interpretations will be discussed.

The data warehouse can control for misinterpretation of data by predefining information (data cubes, reports) and existing rules can control for external data requests (FERPA, Open Records Requests, etc.), but how do we control for an institutional climate of being 'closed' versus 'open' where one Dean wants everyone to have access to data while another does not. Also discussed is the role of the institutional researcher in these issues.

Deriving information from this data may be more of an art than a science, but most would agree that prior knowledge on possible basic patterns can be explicitly or implicitly used in enrollment management. In this paper we use Bayesian inference that explicitly makes use of prior information as a part of our model and predicts Texas Woman's University 12th day total undergraduate re-enrollment within 4% of the actual total.

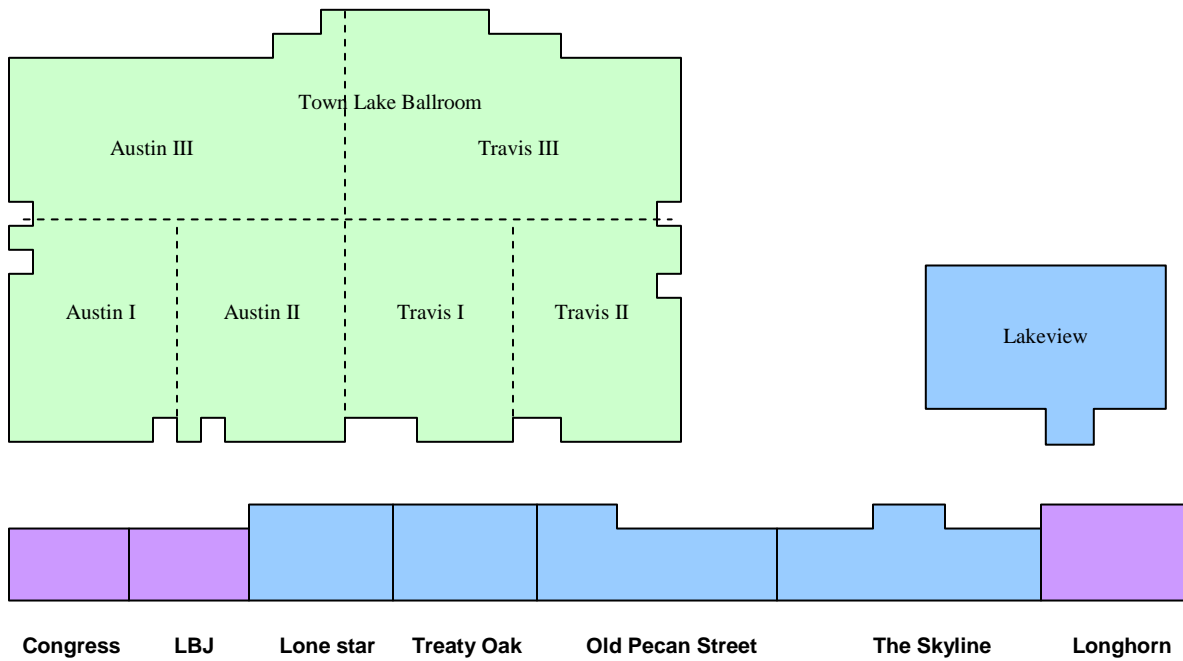
