### **Lubbock History**

Lubbock Since 1890...

 Today Lubbock is a thriving, bustling city of over 200,000 people, but
 200 years ago, the area was covered with tall grasses and roaming buffalo. The region was first discovered and named the Llano
 Estacado in 1540 by the infamous Spanish explorer Coronado on his quest for the "City of Gold".

Lubbock began as two smaller towns until 1890 when "Old Lubbock" and "Monterey" joined together, on a new site, to establish a town consisting of 500 people. This new town, named after Tom S. Lubbock, a Confederate officer, a Texas Ranger, and signer of the Texas Declaration of Independence became the county seat less than a year after being established and officially became a city in 1909. That same year Lubbock residents saw for the first time dark pillars of billowing smoke on the horizon as the first train pulled in to Lubbock from Plainview.

Along with a thriving farming industry, Lubbock made great strides in the cotton industry. The area went from producing 4 bales of cotton in 1902 to producing over 100,000 bales in 1932. Today, Lubbock County produces an astonishing two to three million bales of cotton a year.

In 1923, 30,000 Lubbock citizens fought hard to win the bid to establish a new college, called Texas Technological College. The college opened its doors in 1925 with 1,379 students. In 1976, Texas Tech University expanded with the establishment of the Health Sciences Center Campus which is now a world-renowned medical school. Today, Texas Tech University is a first-class educational and research institution and offering an institution where students can think big, live fully and prepare for tomorrow.

Known as the "Music Crossroads of West Texas", Lubbock has hosted many musical legends, including Lubbock's son, Buddy Holly who attracted followers and inspired musicians all around the world. Other well known West Texas musicians include Mac Davis, Waylon Jennings, Tanya Tucker, Natalie Maines, The Maines Brothers, and Bob Wills.

Teresa Isbell, North Lake College. Teresa Isbell has been involved in institutional research for over twenty years working for community, state and technical colleges in Texas and Arkansas. She is the Dean of Planning, Research and Institutional Effectiveness at North Lake College. She has presented papers and roundtable sessions at TAIR and has presented at SAIR. In 2007 she was a co-presenter of the TAIR 2006 Best Paper at the Association for Institutional Research annual conference. She has served as a member of the TAIR Conference Program Committee from 2003 to 2007. Teresa served as TAIR Member-at-Large for Professional Development from 2005-2007. During her tenure as Member-at-Large, Teresa secured a grant from AIR to improve professional development for TAIR members and enlarged the standard workshop offerings at the annual conference from two to five.
