The division's teams provide **data and research** aimed at informing **policy and practice** to a wide range of constituents, and they ensure that the data pipeline is structured to **meet agency goals and stakeholder needs**.

### COMMUNICATE DATA COLLECTION STANDARDS

Educational Data Center (EDC) receives, cleans then certifies the data

Institutions **report data** to THECB at multiple points throughout the year

### INSTITUTIONS REPORT DATA

DMR staff **analyze and report on certified data** to various stakeholders through multiple means:

- Legislative reports;
- Ad hoc data requests from THECB staff, higher ed institutions, the public, and others;
- Annual reports and data collections (e.g., online Accountability system, Almanac); and more

# Data Modernization Initiative

The goal of the Data Modernization Initiative (DMI) is to equip internal and external stakeholders with **actionable insight and data** to improve decision making capabilities. To meet this goal, THECB staff is creating a one-stop-shop where all data offerings will reside, simplifying data access.



## PUBLIC DATA SITE

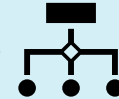
The new Public Data Site features embedded **Power BI dashboards** to give insights via **explanatory and exploratory reports**. The website will also serve as the access point for a **Secure Data Portal** where privileged users can access specially-curated datasets and dashboards.



## SECURE DATA PORTAL

The Secure Data Portal provides internal and external stakeholders access to more robust data through **Secure Dashboards**.

The dashboards **protect the privacy of data** while also providing deeper insights to **improve decision-making capabilities** for each agency or institution.



## SECURE DASHBOARDS

The Secure Dashboards provide each data topic with its own set of dashboards tailored to three user perspectives: **Persistence & Graduation, Transfers, and Labor Market Outcomes**.

Within each dashboard, there are many pages with detailed metrics and tailored insights.

# Secure Dashboards

The Secure Dashboards provide each data topic with its own set of dashboards tailored to three user perspectives: Persistence & Graduation, Transfers, and Labor Market Outcomes.

## PERSISTENCE & GRADUATION

---

The Persistence and Graduation dashboard illustrates institution-specific metrics for **persistence rates, graduation rates, time to degree, and degrees awarded** with the ability to filter by program, demographics, and academic indicators. Users also have the ability to compare results with peer institutions.

These metrics allow users to analyze specific persistence or graduation scenarios or trends over time.

## LABOR MARKET OUTCOMES

---

The Labor Market Outcomes dashboard illustrates metrics pertaining to **student success in the labor market** with the ability to filter by program, demographics, and academic indicators. Users also have the ability to compare results with peer institutions.

These metrics allow users to analyze debt upon graduation, first- and fifth-year wages, median wage by degree level, industries that students go into, and more!

## TRANSFERS IN/OUT

---

The Transfers dashboard illustrates institution-specific metrics for student **transfers in/out of programs at the system or institution level** with the ability to filter by program, demographics, and academic indicators. Users also have the ability to compare results with peer institutions.

These metrics allow users to analyze transfer patterns, hours spent in a program before transferring, GPA before transferring, and more!

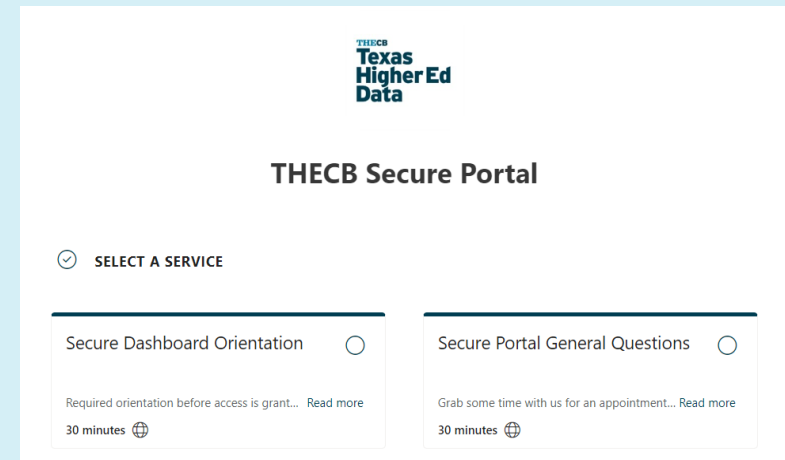
Our team will walk through the Portal and available dashboards with you and answer any questions you have.
