35th Annual Conference Minutes of the Annual Business Meeting Wednesday, February 13, 2013 – 8:00 a.m. Moody Gardens Hotel Galveston, Texas

- **2013-1** Call to Order: The meeting was called to order at 8:13 A.M. by President Carol Tucker.
- **2013-2 Approval of the Minutes from the 2012 Business Meeting:** Amy Bawcom moved to approve the 2012 Business Meeting minutes as presented. The motion was seconded by Tom Martin and passed unanimously.
- 2013-3 Comments from the TAIR President: President Carol Tucker thanked each of the sponsors for sponsoring various events for the conference.
- **2013-4** Amendments to the Constitution and Bylaws: President Carol Tucker asked the membership to review the proposed amendments to the bylaws presented via email and distributed during the breakfast. Faron Kincheloe made the motion, Roy Philbrook seconded and the proposed changes to the bylaws were approved.

President Tucker introduced the Executive Committee and other committee reports.

2013-5 TAIR Executive Committee and other Committee Reports:

Secretary/Membership Report: TAIR Secretary Sue Herring reported there are 208 people registered for the conference and 14 additional members, for a total of 222 TAIR members as of February 13, 2013.

Treasurer's Report: TAIR Treasurer Linda Perez presented a copy of the Financial Report through February 12, 2013 and reported a balance to date of \$53,801.31. Linda explained the report does not include all expenditures and revenues for the TAIR 2013 Conference and the balance will be adjusted once all expenses are finalized. A final report will be presented at the next Executive Committee meeting.

Financial Review Committee Report: Jim O'Donnell reported that TAIR financial records are in order.

Data Advisory Committee: Martha Oburn reported that the TAIR Data Advisory Committee accomplished two major initiatives this past year: the TAIR Data Dictionary was developed and launched on the TAIR website to provide the membership with a comprehensive resource that will serve all colleges and universities in their efforts to provide clear, understandable explanations of the terms that are used in higher education.

Second, all Texas public colleges and universities will feel the impact of the proposed changes in state funding. DAC members have asked for greater clarity and transparency from the THECB as we move into this new era of funding. In addition to clear definitions, plans are being developed to provide institutions with the actual program code that will be used to analyze the data and make calculations.

Technology Report: Dave Downing reported that all systems were up and running. He also said that a new conference registration/management system would be implemented in the next few months.

Professional Development Report: Tom Corll reported that TAIR summer workshops had 47 people in attendance and was held at Texas State University in Round Rock. For the pre-conference workshops, there were 130 participants in 6 workshops. He recognized those members who donated their time to present workshops.

Vice President/Program Committee Chair: TAIR Vice President/Program Committee Chair Susan Thompson began by recognizing and thanking the members of the TAIR Program Committee.
